## Summer kWh Rates

Effective during the months of June through October.

## Winter kWh Rates

Effective during the months of November through May.

## Cycled Air Conditioning

The cycling of a cooling system(s) during the four-month summer credit period (June-September) as needed during peak demand hours. The compressor shall be limited to operating for a 15 minute ON period followed by a 15 minute OFF period.

## Taxes

The rates do not include Wisconsin and county sales tax, which must be added to each bill when applicable by law.
