Win a \$50 bill credit

Saving time and a stamp could mean \$50 for two lucky members this summer. SCEC members who are not currently enrolled in paperless billing (Bill4U) and sign-up between July 1 and Aug. 31, 2015, will be eligible to win one of two \$50 bill credits being awarded to new enrollees.

Bill4U is free and secure for SCEC members. It is available online, 24 hours a day, including as a smartphone app (see QR codes below). Bill4U's features include setting up one-time or automatic payments, and viewing past bills (up to 18 months).


From the Board Room

At their June 1 meeting, the St. Croix Electric Cooperative Board of Directors adopted administrative **Policy 209A Collections**. This policy describes when delinquent amounts owed at one account can be assigned and transferred to a member's other account or to another responsible party. Transferred amounts unpaid will then result in disconnection of the electric service at the account where the amount owed was transferred.

Energy Tips:
Quick DIY tips for summer savings.

- If it's time to switch on the AC, set it at 78°F or as close to 78 degrees as is comfortable.
- Check and replace air conditioning filters.
- Minimize oven use. If it does need to be used, do so in the morning or evening to avoid additional heat in the house, which can make your AC work harder to maintain a comfortable temperature.
- Make sure refrigerator and freezer seals fit tightly when doors close.
- Pool pumps do not need to run 24 hours a day. Any reduction in the time the pump runs translates to electricity savings.
