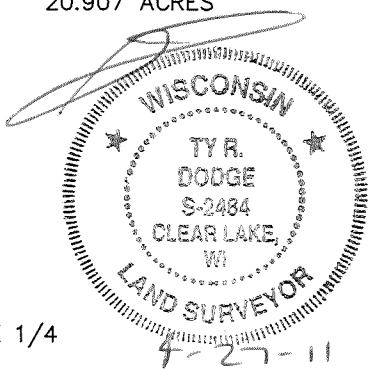
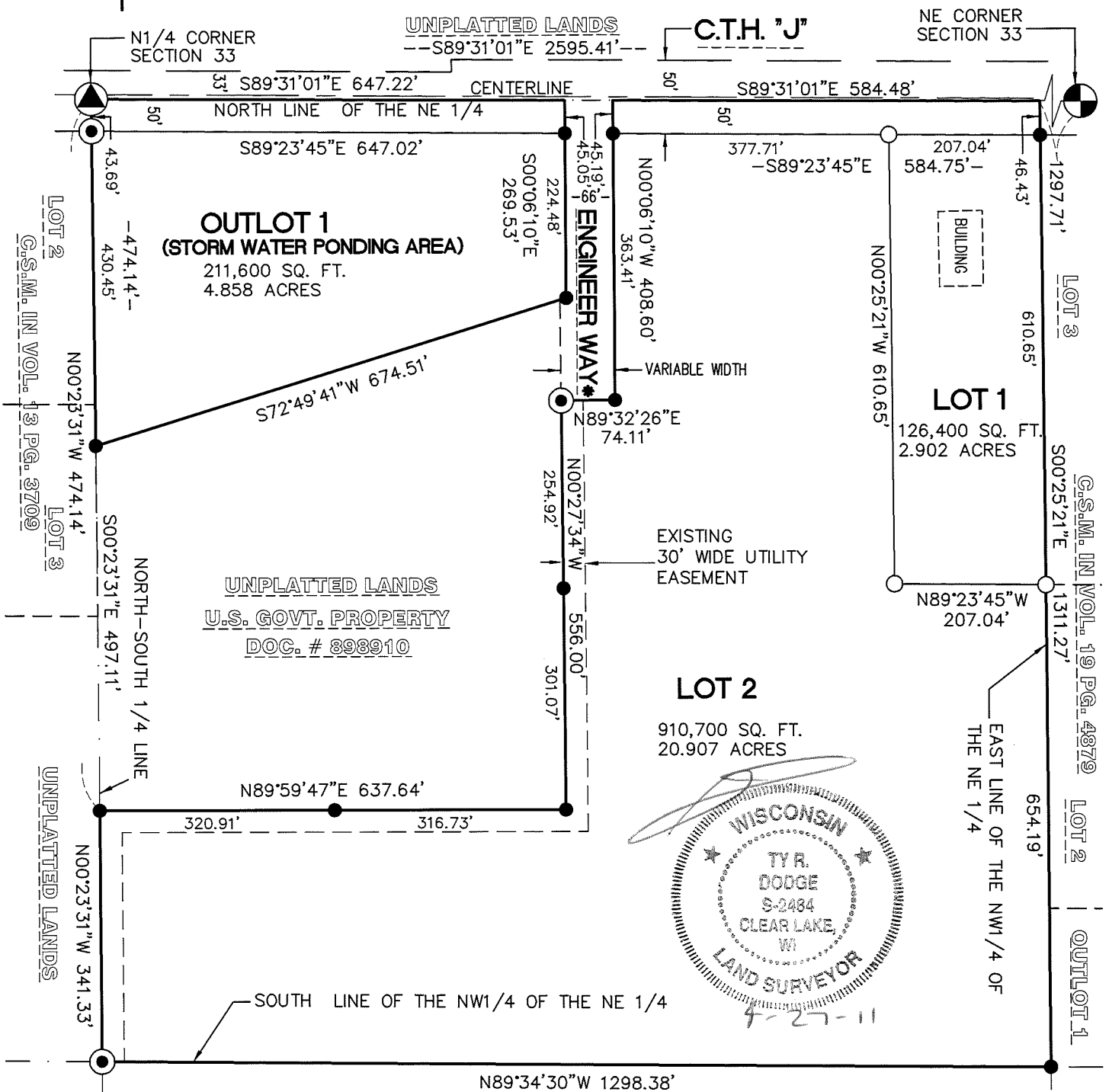
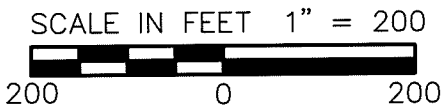

Dodge, Registered Wisconsin Land Surveyor, hereby certify that by the direction of St. Croix Electric Cooperative, I have surveyed, divided and mapped part of the Northwest Quarter of the Northeast Quarter of Section 33, Township 29 North, Range 17 West, Village of Hammond, St. Croix County, Wisconsin, described as follows:

Beginning at the North Quarter corner of said Section 33; thence along the north line of said NE 1/4, S89°31'01"E a distance of 647.22 feet to the west line of Engineer Way; thence, along said west line, S00°06'10"E a distance of 269.53 feet to the northerly boundary of property described in Document #898910; thence, along said northerly boundary, S72°49'41"W a distance of 674.51 feet to the north-south 1/4 line of Section 33; thence, along said 1/4 line and a common line of this description, S00°23'31"E a distance of 497.11 feet to the southerly boundary of property described in Document #898910; thence, along said southerly boundary, N89°59'47"E a distance of 637.64 feet to the easterly boundary of property described in Document #898910; thence, along said easterly boundary, N00°27'34"W a distance of 556.00 feet to the southerly right of way of Engineer Way; thence, along last said right of way, N89°32'26"E a distance of 74.11 feet to the easterly right of way of Engineer Way; thence, along said right of way, N00°06'10"W a distance of 408.60 feet to said north line of the NE 1/4; thence, along said north line, S89°31'01"E a distance of 584.48 feet to the east line of said NW 1/4 of the NE 1/4; thence, along last said east line, S00°25'21"E a distance of 1311.27 feet to the south line of said NW 1/4 of the NE 1/4; thence, along last said south line, N89°34'30"W a distance of 1298.38 feet to said north-south 1/4 line; thence, along said 1/4 line, N00°23'31"W a distance of 341.33 feet; thence, continuing along said 1/4 line and aforesaid common line, N00°23'31"W a distance of 497.11 feet; thence, along said 1/4 line, N00°23'31"W a distance of 474.14 feet to the point of beginning.
